

**30 YEAR CEILING &
SUSPENSION SYSTEM
LIMITED WARRANTY**



Armstrong World Industries Pty. Ltd. (ACN 000 361 679) guarantees the Armstrong HumiGuard Plus (RH 99) ceiling panels item number () & Armstrong Prelude XL/Suprafine XL for a 30 year period under certain limiting conditions. The warranty covers issues associated with visible ceiling panel sagging & warping & rust (greater than 50% red rust as defined by ASTM B117) & against manufacturing defects subject to further conditions outlined below:

- 1. The materials (panel and suspension system) are used together.
- 2. Materials shall be purchased from an approved distributor and installed by an approved contractor and in accordance with the Armstrong Installation & Maintenance Guide.
- 3. Damage which may occur from chemical fumes, freezing temperatures, vibration and abuse is not covered by this warranty.
- 4. Installation shall be carried out in temperatures above 0°C and below 49°C and relative humidity

99% or less. Following installation, the environmental conditions shall be controlled within the said limits of 0-49°C. HumiGuard Plus ceilings cannot be used in exterior applications, where standing water is present or where moisture will come in direct contact with the ceiling.

- 5. Damage caused from direct moisture in the form of building leaks or condensation is not covered by this warranty.
- 6. The acoustical material shall not support any other material.
- 7. Prior to installation, the material must be kept clean and dry, flat and within the temperature range of 0-49°C and no greater than 99% relative humidity. Large variations in humidity or temperature can result in swelling and shrinkage. Any material stored on the floor should be level, flat and have a protective barrier between material and the floor.

Should the Armstrong material be deemed defective, written notice within thirty (30) days after first

observing such fact must be given to Armstrong World Industries Pty. Ltd., 99 Derby Street, Silverwater, NSW 2128 Australia, (P.O. Box 6765), and after inspection and/or verification, Armstrong World Industries Pty. Ltd. shall furnish new material at its own expense of the same type and grade in an amount equal to that which is deemed defective.

The furnishings of such material shall constitute the total liability of Armstrong World Industries Pty. Ltd. hereunder and, without limitation, Armstrong shall not be responsible for any installation or replacement costs or for incidental or consequential damages of any nature whatsoever.

The foregoing constitutes the entire guarantee by the Armstrong World Industries Company. All other warranties or guarantees, expressed or implied, including any guarantee that the goods are merchantable or fit for a particular purpose are hereby excluded.
